Instructions

1. The electronically certified visit requests from one of the approved channels: (chambers of commerce, government agencies that have an access account on the platform) are automatically sent to the ministry to be processed, and there is no need to send the request on paper to the Ministry of Foreign Affairs, review it or one of its branches, and the status of the request can be monitored through Location

2. The visit requester undertakes that the information recorded is correct and that the requested person will leave before the end of the specified period of the visit, and that for the duration of his stay in the Kingdom he shall be subject to the laws and regulations in force, and that the purpose of the request is for the visit only and not for work or pilgrimage, and I bear the responsibility if it is proven otherwise

The government of the Kingdom of Saudi Arabia requires institutional quarantine for those wishing to come to it from countries from which entry has not been suspended, with the exception of

- Male and female citizens, the male's wife, the female's husband, the male and female sons and daughters, and the domestic workers accompanying any of the aforementioned categories
- .Unprotected domestic labor accompanying an immunized resident
- .(Immunized (those who received all doses of vaccines approved in the Kingdom
- .official delegations
- .Those holding diplomatic visas, diplomats and their families residing with them
- .Air navigation crews
- .Truck drivers and their assistants from all ports
- .Who has a relationship with health supply chains, according to what the Ministry of Health sees
- .Naval ship crews

.Those whose health condition appears (vaccinated) and their companions under the age of 18 years •

The period of institutional quarantine for all those coming from outside the Kingdom, with the exception of the above-mentioned categories, is for a period of 5 days, to be calculated from the hour of arrival at the institutional quarantine headquarters and at the expense of the traveler

With an emphasis on the necessity of obtaining a valid health insurance policy to cover the risks of the Coronavirus, approved by the official authorities in the Kingdom, for all those coming to the Kingdom (unvaccinated), and these procedures will be implemented as of Thursday, Shawwal 8, 1442 AH, corresponding to May 20, 2021 AD
